- 1. This inspection is conducted under the authority of Arizona Revised Statues (A.R.S.) 32-2108.A and 32-2175.H.

- 9. The information and documents provided during an audit or investigation become a public record. You may redact trade secrets and proprietary and confidential information unless the information and documents are confidential pursuant to statute.

- 11.` You have the right to appeal a final decision of the ADRE if any administrative order is issued or other enforcement action is taken based on the results of this inspection.
